



General

(a) The contract is for the hire and/or sale of equipment detailed in the contract. The parties to the contract are:

- (i) The Hirer, an individual or an organisation whose official representative will be the signatory of the contract.
- (ii) Beyond Vintage Limited (BV) Registered No. 8051675, registered office at 1st Floor 2 Woodberry Grove, Finchley, London N12 0DR.

(b) All equipment hired remains the property of BV at all times. Purchased equipment remains the property of BV until BV receives full payment.

(c) Where the Hirer is in breach or subject to insolvency or liquidation proceedings, BV may immediately terminate the contract and collect equipment without affecting any rights to recover monies owing or breach of contract damages.

Charging

(a) Hire charges will be for periods of 3 days (72 hours) or multiples as agreed in writing and as detailed on the hire contract. All charges quoted are VAT inclusive at the current rate if applicable

(b) Delivery and Collection will be charged at rates agreed between the parties in writing. Failed delivery and collection attempts will each be charged at the agreed rates.

(c) All outstanding payments to be paid on demand any delay will attract a daily penalty based upon interest incurred or loss of hire income by BV or charge of £10 a day, whichever is the greater.

(d) A 50% deposit will be requested as security for booking. Full payment is required 4 weeks prior to hire. At least 6 weeks notice is required for full or part cancellation of the contract or full charges may be levied.

(e) Any equipment unavailable for inspection, collection or return, after a reasonable time, will be deemed to be lost and a charge will be made to the Hirer equal to the current replacement value of the item/equipment. The Hirer agrees to pay for all equipment lost, repairs and/or cleaning. Hire charges will



continue until full payment is made.

The Hirer

(a) If required adequate delivery and collection access will be provided by the Hirer. Any loading, unloading, set up or break down assistance provided by BV is at the Hirers risk.

(b) The Hirer or his signatory will check quantities and condition of equipment on upon delivery. Any damage or shortfall must be agreed, noted on the contract and signed off by both parties.

(c) The Hirer accepts full responsibility for the security and safe use of the equipment until collection or return to BV.

(d) The Hirer agrees to insure or be held responsible for all equipment hired on a full replacement basis against loss and theft. All insurance claim proceeds to be paid to BV on demand.

(e) The Hirer agrees to pay for any breakages, items charged at double the hire rate as shown on the invoice.

(f) The Hirer agrees to return items in the crates/boxes supplied by BV, any loss of plastic storage crates will be charge at the rate of £10 per crate.

Beyond Vintage Limited (BV)

(a) Agreed hire rates will be maintained once quoted in writing for a maximum period of 6 months or until expiry of the contract.

(b) Appropriate instruction on the safe use and operation of the equipment will be provided where applicable by BV.

(c) All powered equipment will undergo appropriate testing and inspection in accordance with relevant statutory requirements prior to commencement of hire.

(d) Whilst BV will make every endeavour to supply equipment as described in the current catalogue and website, all items are offered subject to availability. Circumstances may lead to alternative products being supplied, but they will conform to the same standards.



(e) If equipment cannot be supplied on the agreed date because of circumstances beyond its reasonable control, BV shall return all monies paid and not be liable to pay further compensation to the Hirer.

(f) The liability of BV for any claims made by the hirer will not exceed the contract charge and does not extend to any consequential or financial loss caused by late or non-delivery, unsuitability, breakdown or lawful repossession.
